

Affidavit of service filed in Court today is taken
on record.

This is an application for contempt arising
from an order dated **November 4, 2025**.

Mr. Srijib Chakraborty, learned advocate
appears for the petitioners.

Mr. Parashar Baidya, learned advocate appears
for all the contemnors but except the contemnor no. 1
as the contemnor no. 1 has resigned from her post on
January 21, 2026. The concerned notification has
already been published for the new incumbent to join
and take charge for the post of the alleged contemnor
no. 1 but the new incumbent has not yet taken
charge.

The learned advocate appearing for the alleged
contemnors shall furnish the details and particulars

of the new incumbent **Sri. Arunasish Goswami** to the petitioners advocate on record immediately after he takes charge for the post. (1)

On the prayer of Mr. Srijib Chakraborty, learned advocate appearing for the petitioners supplementary affidavit filed in Court today is taken on record. Copy has been served upon Mr. Parashar Baidya, learned advocate appearing for the contemnors in Court today.

The order speaks for itself.

The sum and substance for the concern of this Court is the protection of the interest of the students and their career who are the future of the nations.

After hearing the submissions made by Mr. Srijib Chakraborty, learned advocate appearing for the petitioners and Mr. Parashar Baidya, learned advocate appearing for the alleged contemnors and on the basis of the proposal submitted on behalf of the alleged contemnors following directions are made:

- (a) There are total 77 numbers of students altogether belongs to the particular college, namely, **Deben Mahato Teachers' Training Institute (B.Ed) College** for the concerned academic year who must and should be registered as the registered students of the concerned University, namely, **Baba Saheb Ambedkar Education University;** (2)

- (b) The first trnch of **25 numbers** of students with all their relevant documents shall visit the office of the Registrar of the concerned University positively on **February 27, 2026** so that their registration process can be completed by the University. In the event, any deficiency is discovered for any single student, such student must be given to a further opportunity to cure it but positively within next **seven days**;
- (c) The second trunch of **25 numbers** of students with all their relevant documents shall visit the office of the Registrar of the concerned University positively on **March 5, 2026** so that their registration process can be completed by the University. In the event, any deficiency is discovered for any single student, such student must be given to a further opportunity to cure it but positively within next **seven days**;
- (d) The last trunch of **25 numbers** of students with all their relevant documents shall visit the office of the Registrar of the concerned University positively on **March 10, 2026** so that their registration process can be completed by the University. In the event, any deficiency is discovered for any single student, such student must be given to

a further opportunity to cure it but positively within next **seven days**;

All formalities which are required to be carried out in view of the rules and regulations of the University including payment of fees or charges, if any, shall have to be carried out and complied with by the students in accordance with law. If the records shows that fees and charges have already been paid by the students no further sum can be collected from them.

The entire registration process for all the 77 students must and should be completed by the University positively on or before by **March 31, 2026**.

Upon completion of the registration of the students they shall also be informed accordingly with their registration number and registration document, if any, by sending e-mails to their individual respective e-mail id by the University.

The composite notice giving details of the registration number with other allied particulars, if any, required shall also be published physically in the notice board of the University which shall be kept in the notice board for next one month.

The University shall also publish a copy of today's order and the final notice granting registration to the students in its website.

It is also made clear that students for the said purpose the University shall also publish a copy of today's order along with the particulars of 77 numbers of students with their names and other particulars available to the University referring the name of the concerned college positively by **February 24, 2026.**

The alleged contemnor no. 2 shall file a compliance report enclosing all the relevant documents and notifications as directed herein to be published on the next day before this Court by way of an affidavit.

The petitioners shall be at liberty to take steps to implead the new incumbent at the appropriate stage as the alleged contemnor in accordance with law.

The matter shall appear under the heading "**Contempt Application**" on **April 10, 2026.**
